




Corcoesto Project | Overview

- Located 35km W of the La Coruna in NW Spain, one of the most promining regions
- 100% ownership
- 2011 NI43-101 Compliant Resource
 - Measured & Indicated: 325,000oz Gold
 Inferred: 1,149,000oz Gold



- Extensive work Completed on the project, over 42,000m of drilling
- Excellent infrastructure; roads and 22 Kv power line crossing project
- Scoping study led by Ore Reserves Engineering underway
- Active multi-rig infill/exploration drill program underway
- Potential for both open pit and underground operations



A total of 1,101.9 m of surface trenching in 55 trenches, 443.1 m of adit sampling in 4 adits and 42,326.2 m of diamond and RC drilling in 436 drill holes were used in the resource with sample spacing's that were less than 30 m for Measured resources, less than 40 metres for Indicated resources and less than 195 m for Inferred resources except for Inferred resources below 200 m from surface and for the northern two vein systems that used drill spacing's of 196 m

A base cutoff grade of 0.65 g/t Au was used for reporting resources above a depth of 200 m from surface and a cutoff grade of 2.0 g/t Au was used for reporting resources below 200 m from surface




Corcoesto | Scoping Study Progress



- Resource estimate completed in June 2011 showed an increase of resources of 400%
- Conceptual sitings for Tailings Storage Facility: Complete
- Open Pit\Underground Design: In-progress
- Plant Design: In-progress
- Preliminary Metallurgical Test Program: In-progress
- Conceptual Plant Capital and Operating Costs: In-progress
- Environmental Studies and Permitting: In-progress
- Economic Analysis: In-progress

Enchi Gold Project

- Located in **Ghana**, 70km SW of the 5Moz Chirano gold mine associated with 9km long Bibiani Shear Zone
- Spending \$5M to earn net 51% interest from Kinross Gold

Corp(TSX:K)

- Mid-stage exploration comprised of 8 licenses totalling 568km²
- 290km west of the capital city Accra, accessed via sealed roads

Enchi | Location

- Analogous to Chirano Gold Mine
- Enchi hosts 16 known targets along a 40km section of the Bibiani Shear
- Enchi Gold Project is +500 square km
- ~15,000m of drilling completed mainly focusing on Boin, Nyam and Sewum
- Key Target Areas:
 - Boin
 - Nyam
 - > Sewum

Enchi | Boin & Nyam Gold Zones

- +10 km of continuous gold mineralization identified on Boin
- +1.7 km of mineralization drilled to date on Nyam
- Consistent widths of 10 20m of low grade gold intercepted in drilling
- 43-101 resource estimate planned for Q4, 2011
- Gold zones open both on strike and at depth
- Phase II drilling underway targeting on-strike extensions both north and south and drilling deeper 150-250m holes under known lower grade zones on both Boin and Nyam







- Sewum has some of the highest gold geochem anomalies on the Enchi Project
- RC Drilling identified gold mineralization
 over +5km long Sewum South North
- Edgewater diamond drilling campaign underway
- 56 drill holes most assays still pending

Summary

- Ghana Enchi Gold Project: located in one of the most prolific gold regions of the world; major resource delineation and new gold target drilling program. A 35,000m Diamond drilling program underway
- Spain Advanced stage 100% controlled Corcoesto gold deposit: hosts a recently updated NI 43-101 M&I resource of 325,000 oz Gold with 1,149 oz Gold of Inferred, the deposit is open for resource expansion and is potentially amenable to low cost open pit mine development. A 12,000m Diamond drilling program underway. Edgewater recently commenced a scoping study on Corcoesto to be completed H2, 2011.
