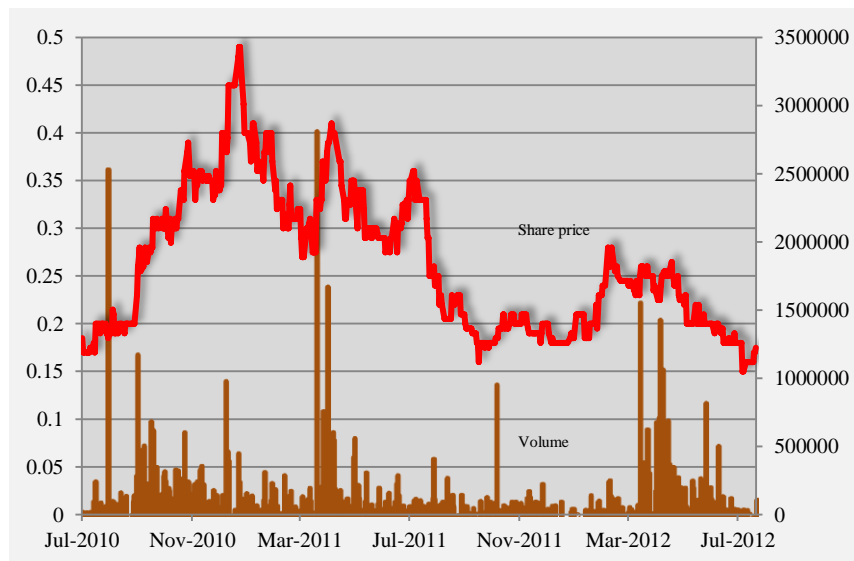

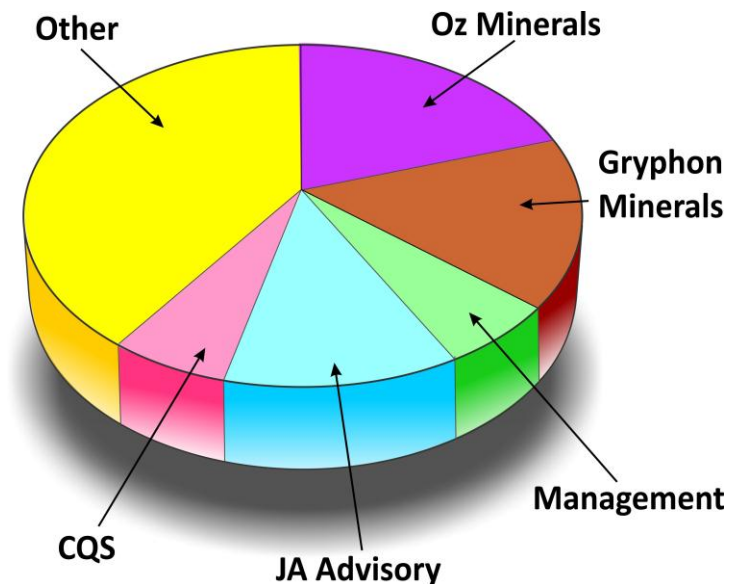

Cambodia | An Emerging Country



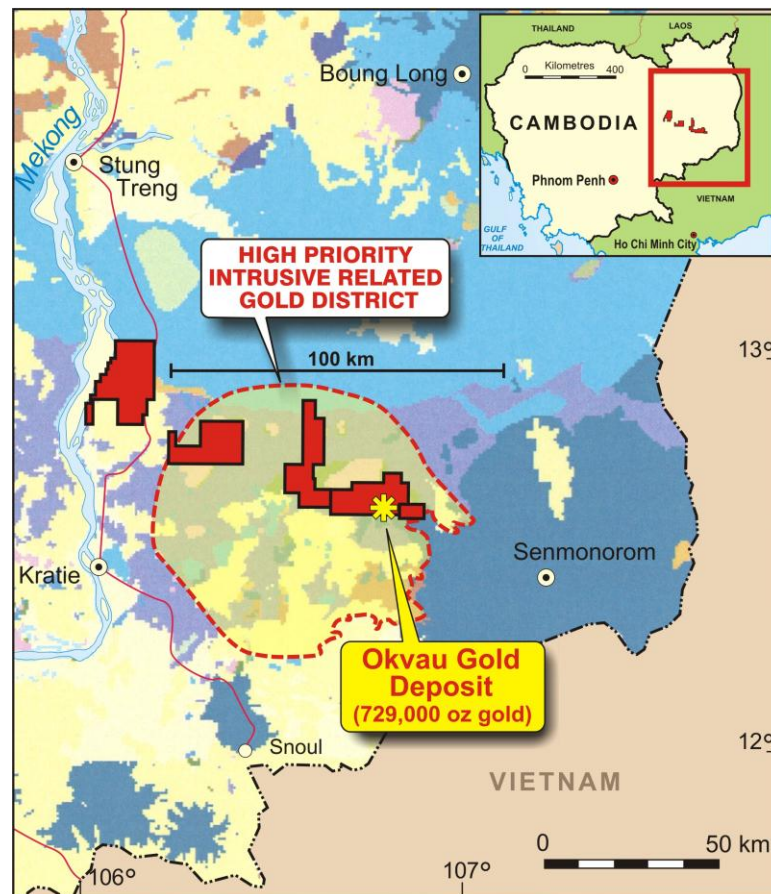
“One of the most liberal investment regimes in Asia” - US Government

- Cambodia remains unexplored with modern exploration only recently commencing in 2006/07
- Prospective for world class mineral discoveries, particularly large gold deposits
- Stable pro-development, **pro-mining government**
- Peaceful democratic elections since 1993 recognised as free and fair
- Modern mining governance regime
- Corporate tax rate for mining companies of 30%
- Gross revenue royalty of 2.5%
- First mover advantage with established in-country team



Project Overview | “A New Intrusive Gold Province”

- Substantial holding of 1,100km² of prospective virgin exploration terrain
- Located in the sparsely populated eastern region of Cambodia approximately 265kms north-east of Phnom Penh
- Main licences (Okvau and O Chhung) held 100%

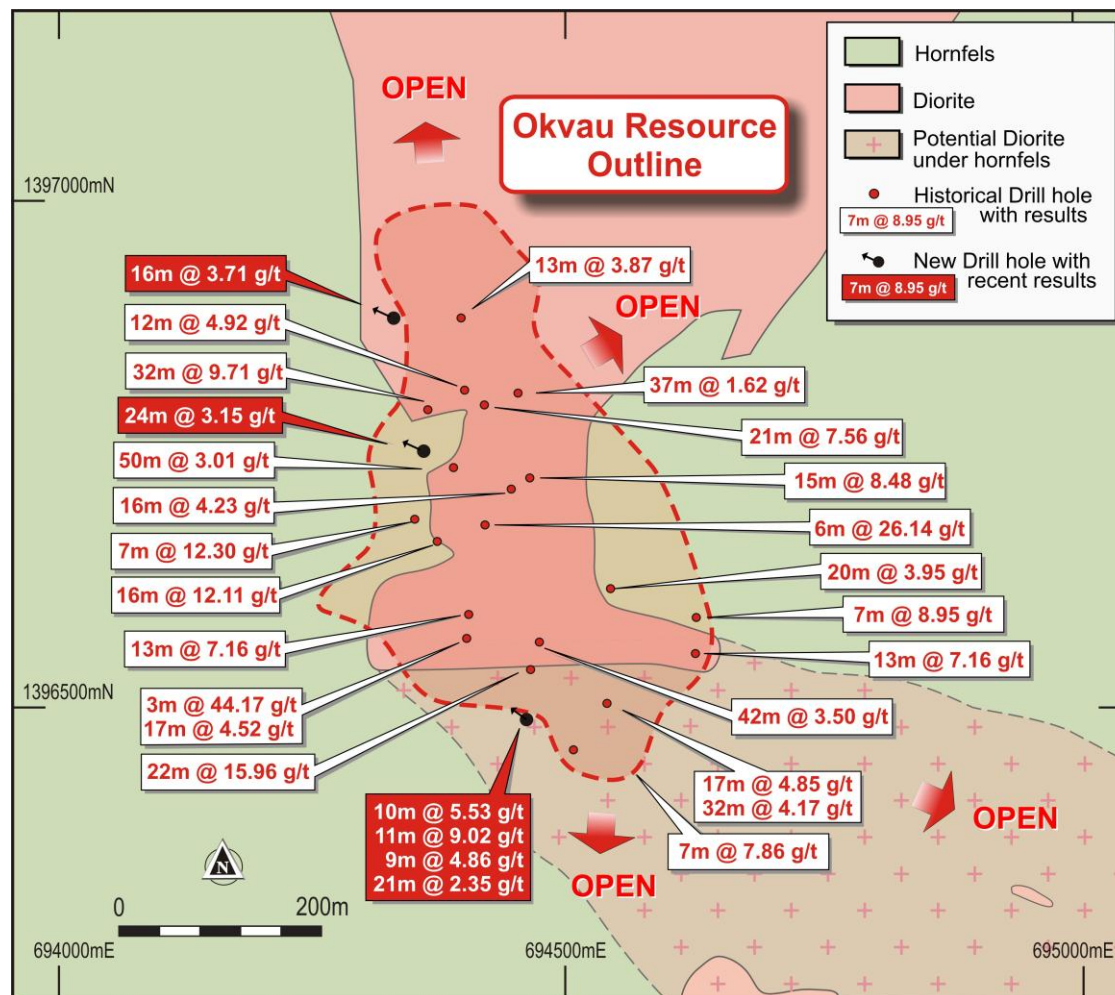


- Key similarities with the Tintina Gold Belt (Alaska-Yukon):
 - Donlin Creek 38Moz @ 2.3g/t
 - Fort Knox 10Moz @ 0.8g/t
 - Pogo 6Moz @ 18g/t
 - Livengood 20Moz @ 0.6g/t

Independent Resource estimate of **12.6Mt @ 1.8g/t** for 730,000 oz gold



70% of resource classified as 'Indicated' at >2.0g/t gold

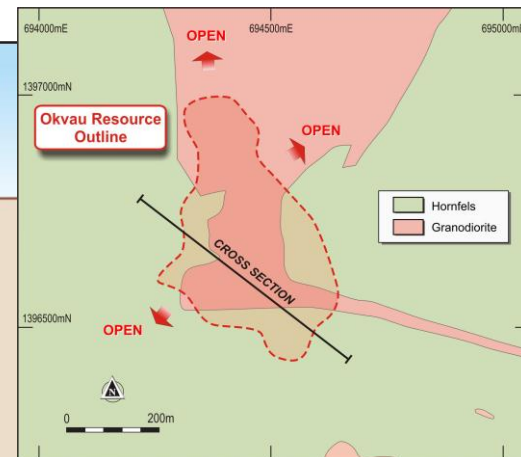
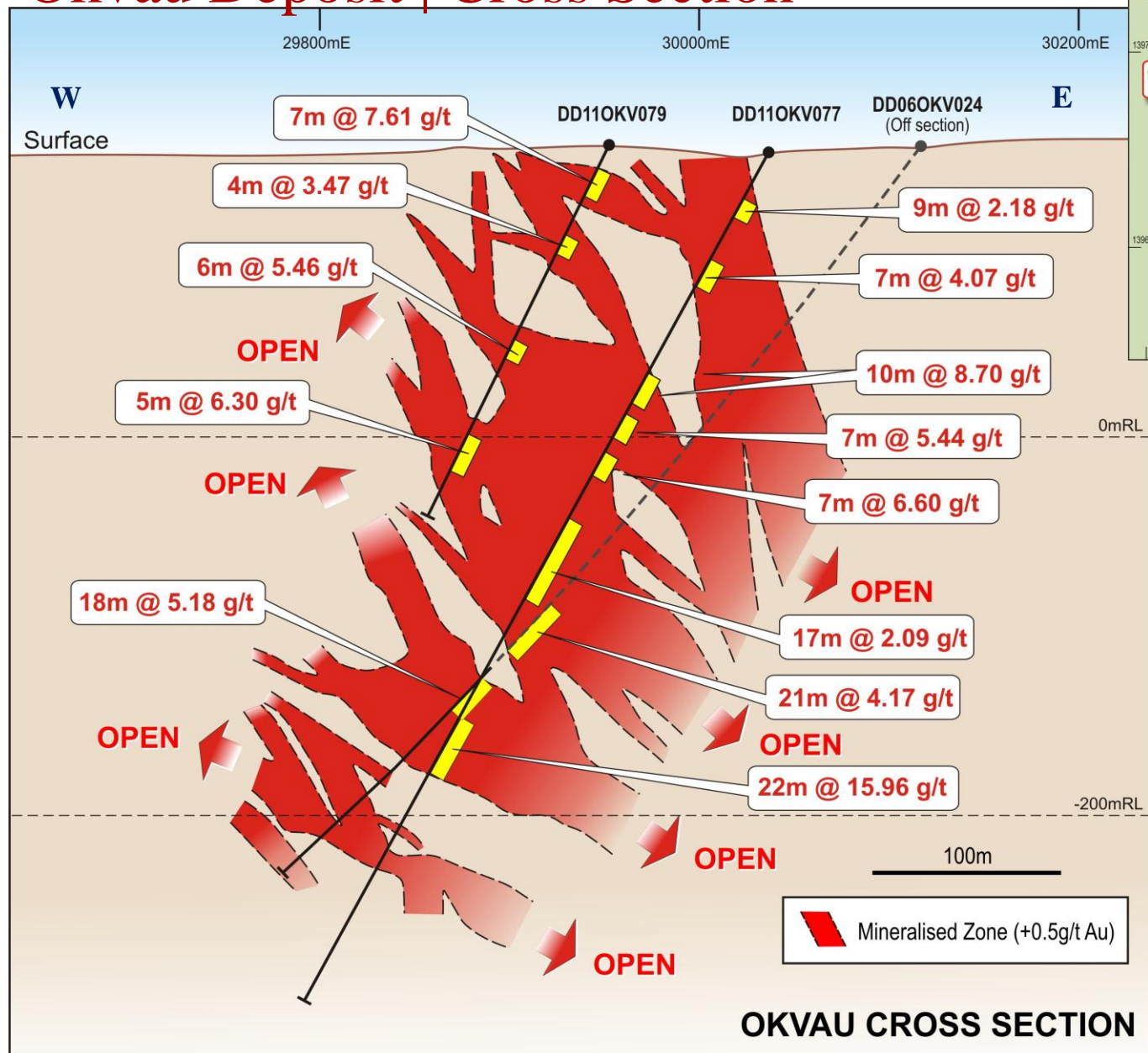
Mineralisation starts at surface

'Open' to north, south and down dip

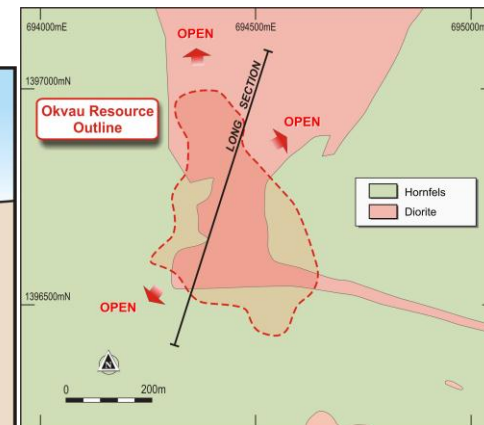
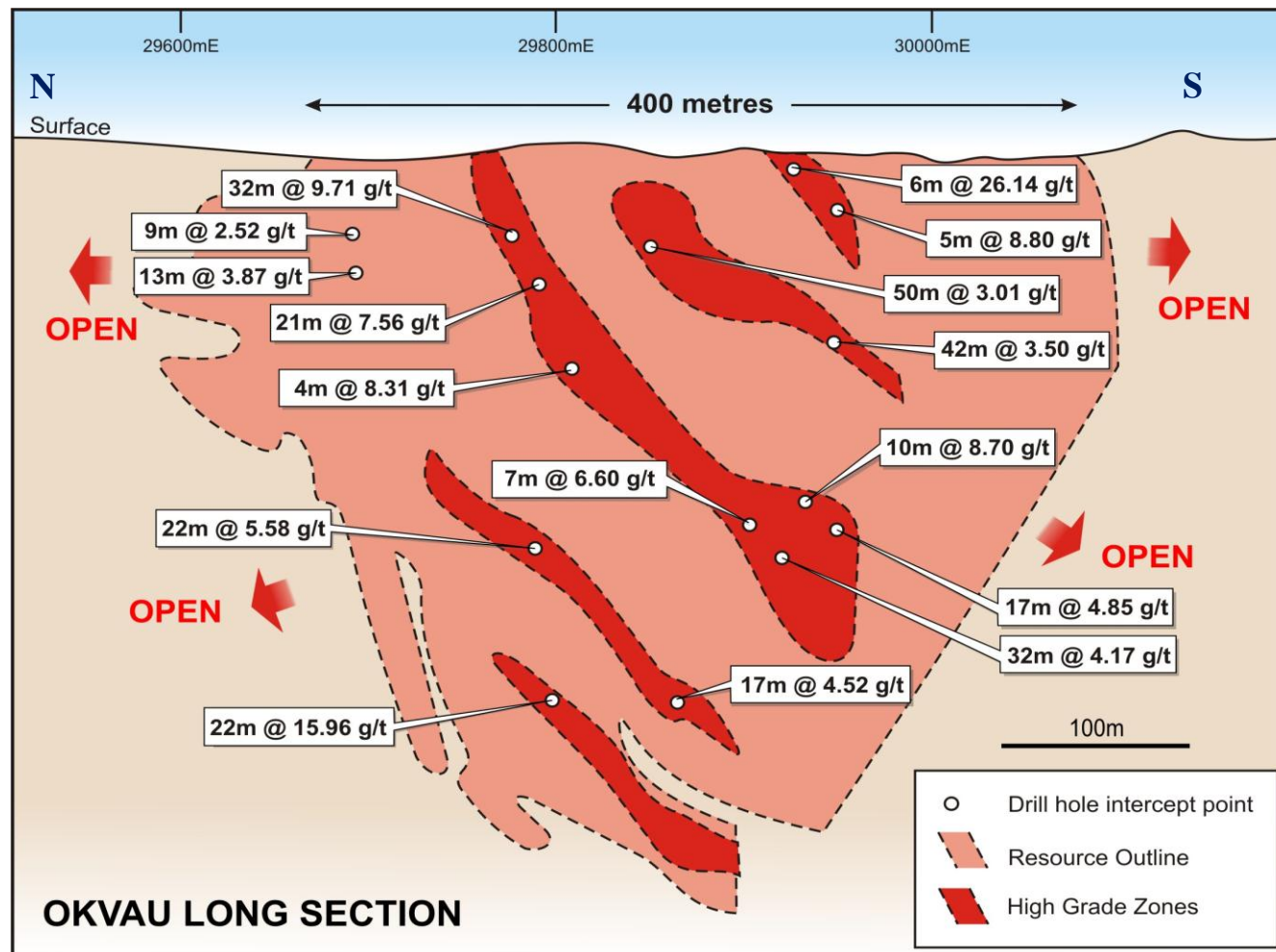
Results from current **step-out drilling** include:

- 16m @ 3.7g/t fr 13m
- 24m @ 3.2g/t fr 209m
- 10m @ 5.5g/t fr 194m
- 11m @ 9.0g/t fr 230m
- 9m @ 4.9g/t fr 294m

Okvau Deposit | Cross Section



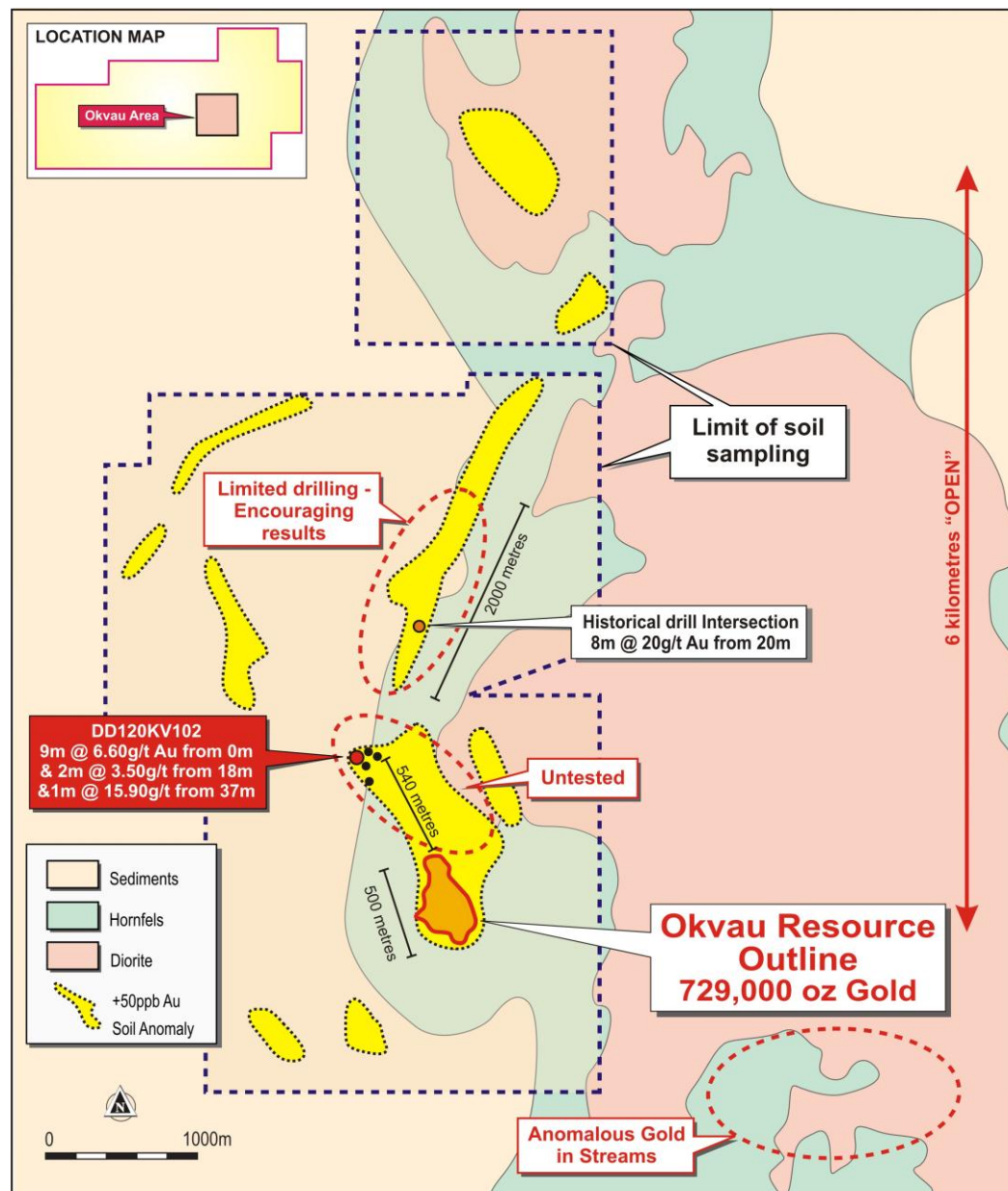
Okvau Deposit | Long Section



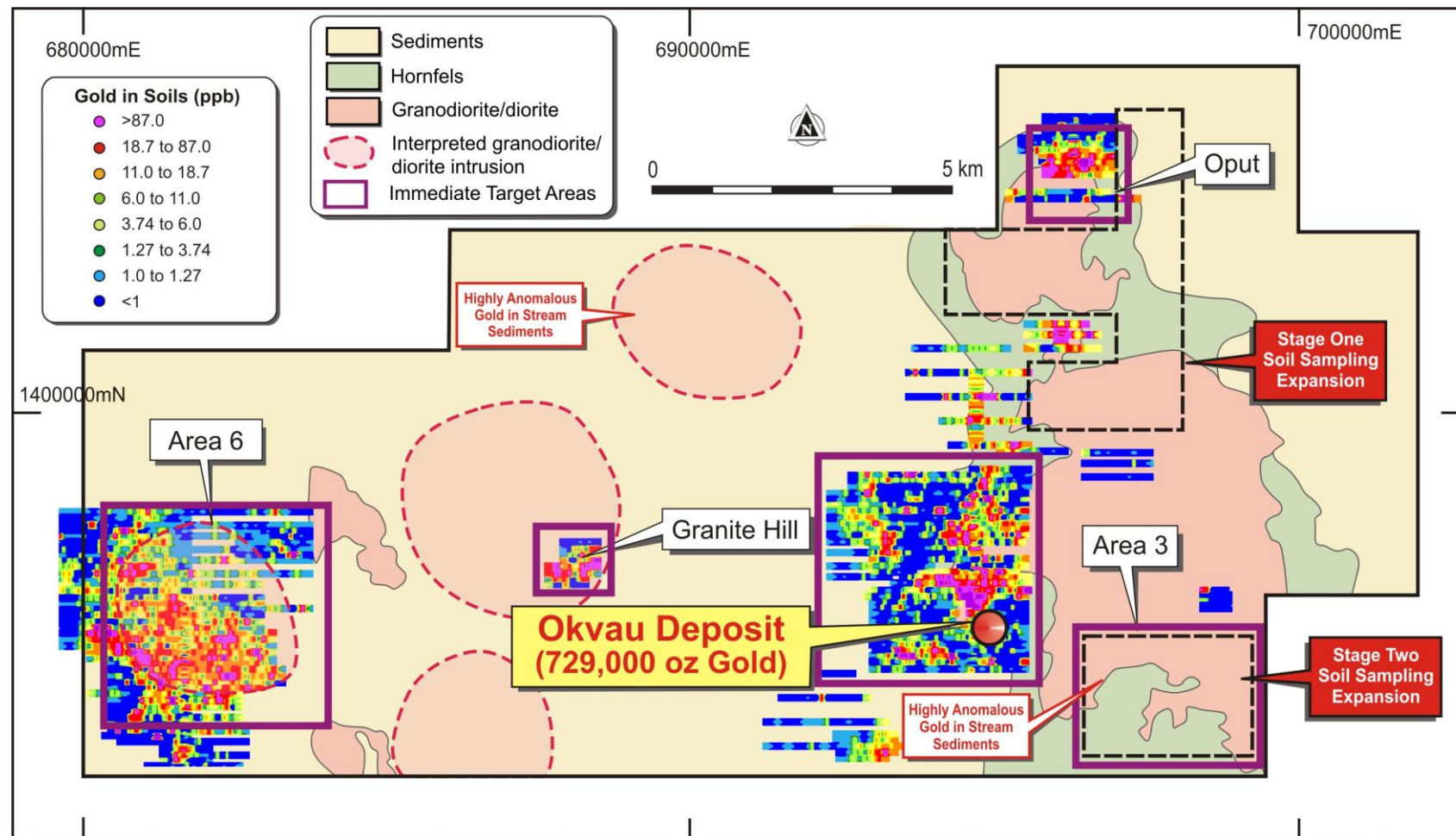
- 90% of current resource estimate contained from surface to 250mbs
- Over 2,500 ounces of gold per vertical metre
- Grade, widths and continuity improving at depth

Okvau Deposit | Near Resource Targets

- Gold in soil anomaly continues north of Okvau resource for +2km
- Reconnaissance drilling intersections include **8m @ 20g/t Au from 20m**
- No follow up drilling
- **Potential for significant expansion of Okvau resource**



Satellite Targets | New Discovery Potential



- Okvau was the first prospect drilled which resulted in a major discovery
- High priority targets within 15km of Okvau resource remain untested
- Additional anomalies and targets expected from expansion of soil geochemistry

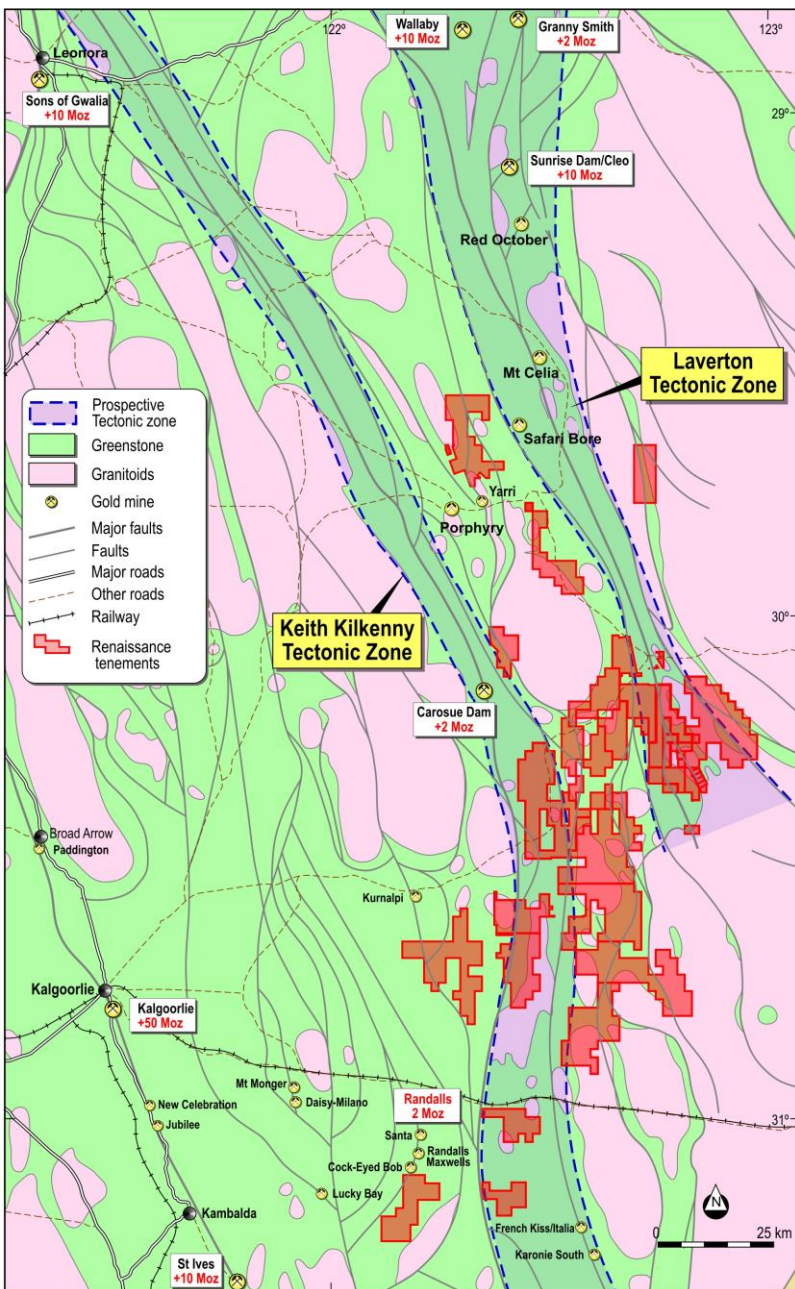

Eastern Goldfields Project, Western Australia



- Substantial and dominant regional 2,700km² tenure, largely 100% owned by Renaissance
- Positioned on two regional scale gold corridors: Keith-Kilkenny & Laverton Tectonic Zones
- Prospective for multi million ounce gold systems
- Underexplored due to shallow cover and previous complex ownership
- Recent drill results include:
 33m @ 3.10g/t Au from 51m;
 32m @ 2.61g/t Au from 13m;
 12m @ 2.96g/t Au from 73m;
 22m @ 1.74g/t Au from 12m;
 8m @ 2.04g/t Au from 126m

Summary | Preliminary Work Plan

- **Step out drilling** on cornerstone Okvau deposit (underway) – ongoing results
- Okvau resource increase to **+1M oz within 6 months**
- **Drilling on satellite targets to demonstrate multi million ounce potential**
 - 8m @ 20g/t gold
 - 5m @ 14.9g/t gold
- New regional exploration (mapping, geophysics, geochemistry) - ‘**virgin gold district**’
- Targeting a new ‘Okvau scale’ discovery within 12 months
- Attractive **EV/oz multiple of <A\$30/oz** - well below peer average with potential short term re-rating
- **Aggressive drilling** program underway in Cambodia
- Significant **supportive corporate & institutional shareholders**
- Management team with a **proven track record**
