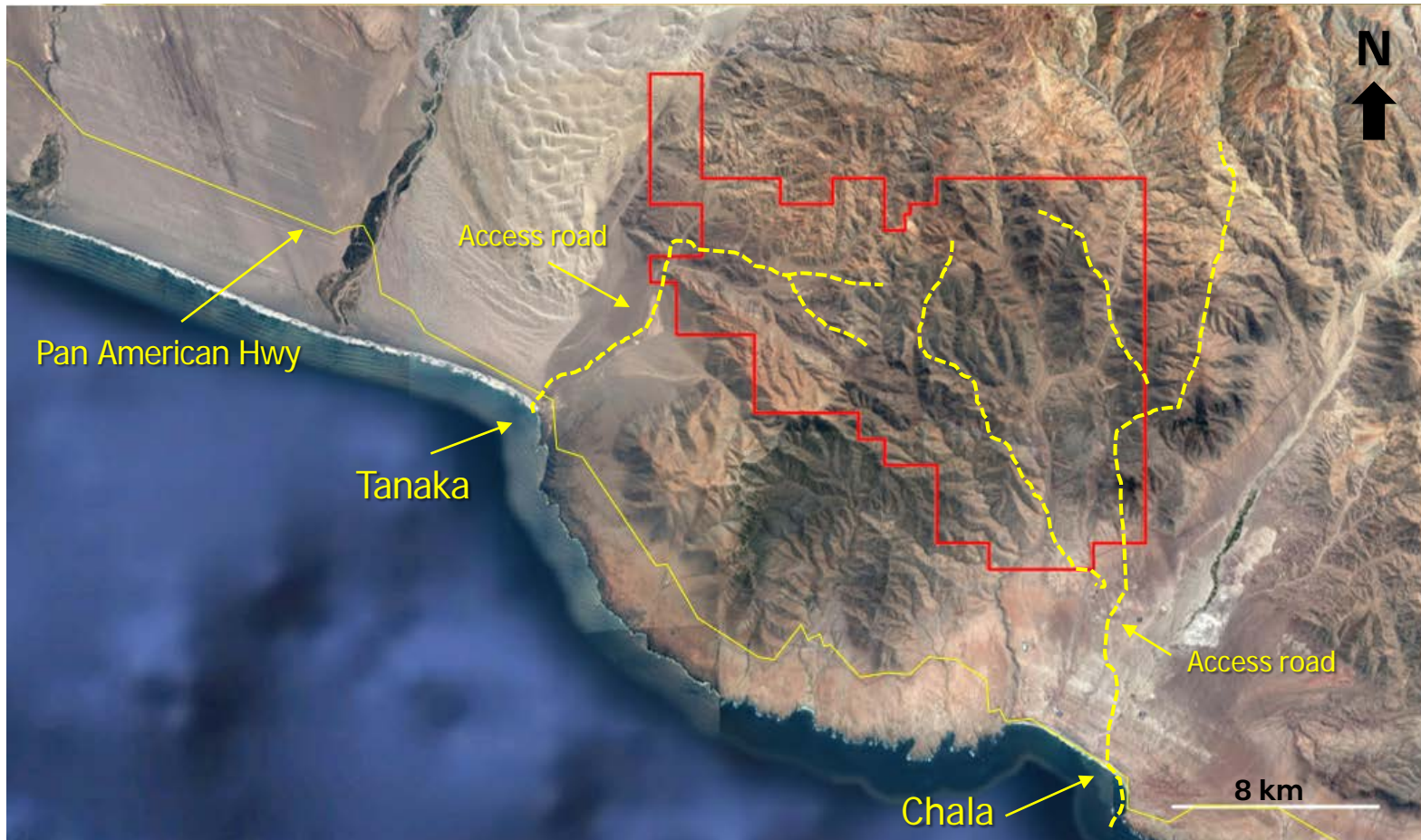
- Camino holds the Chapitos Cu-Au, Villa Hermosa Au and the Los Dorados Cu-Au projects in Peru

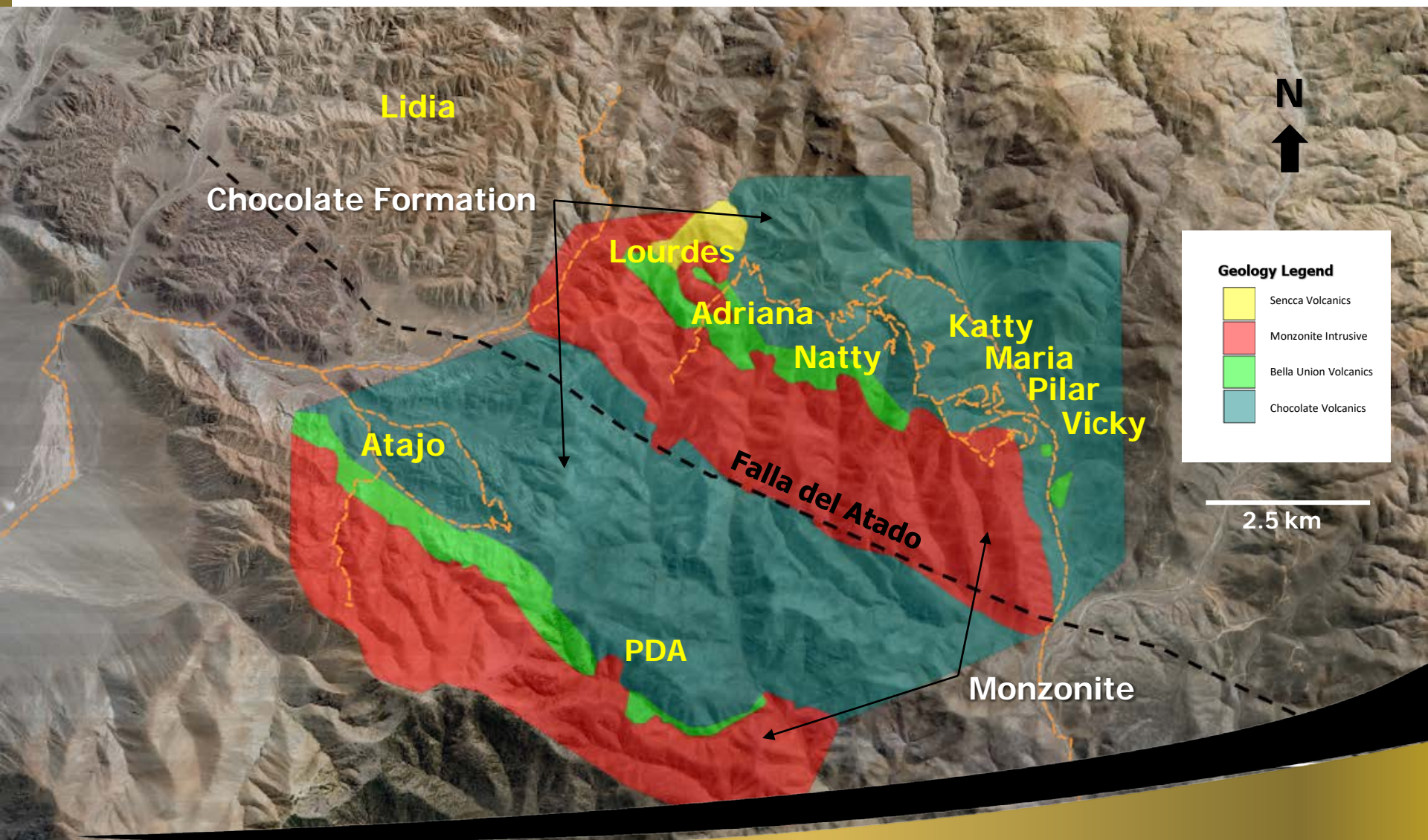


# LOS CHAPITOS - LOCATION

- Located 8 hours south of Lima on the Pan American Hwy, accessible 15 km from either Chala or Tanaka



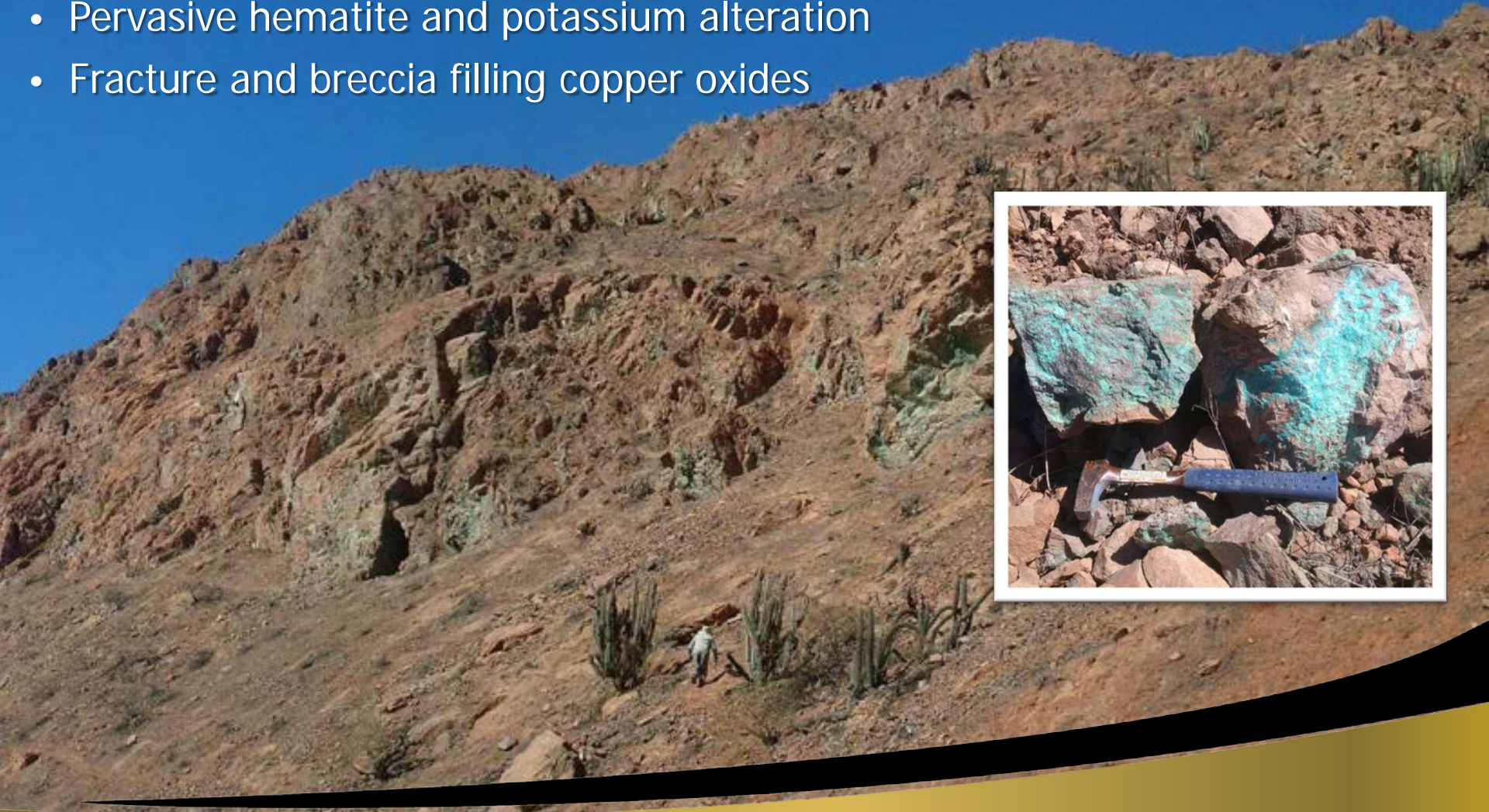




# ADRIANA DISCOVERY OUTCROP

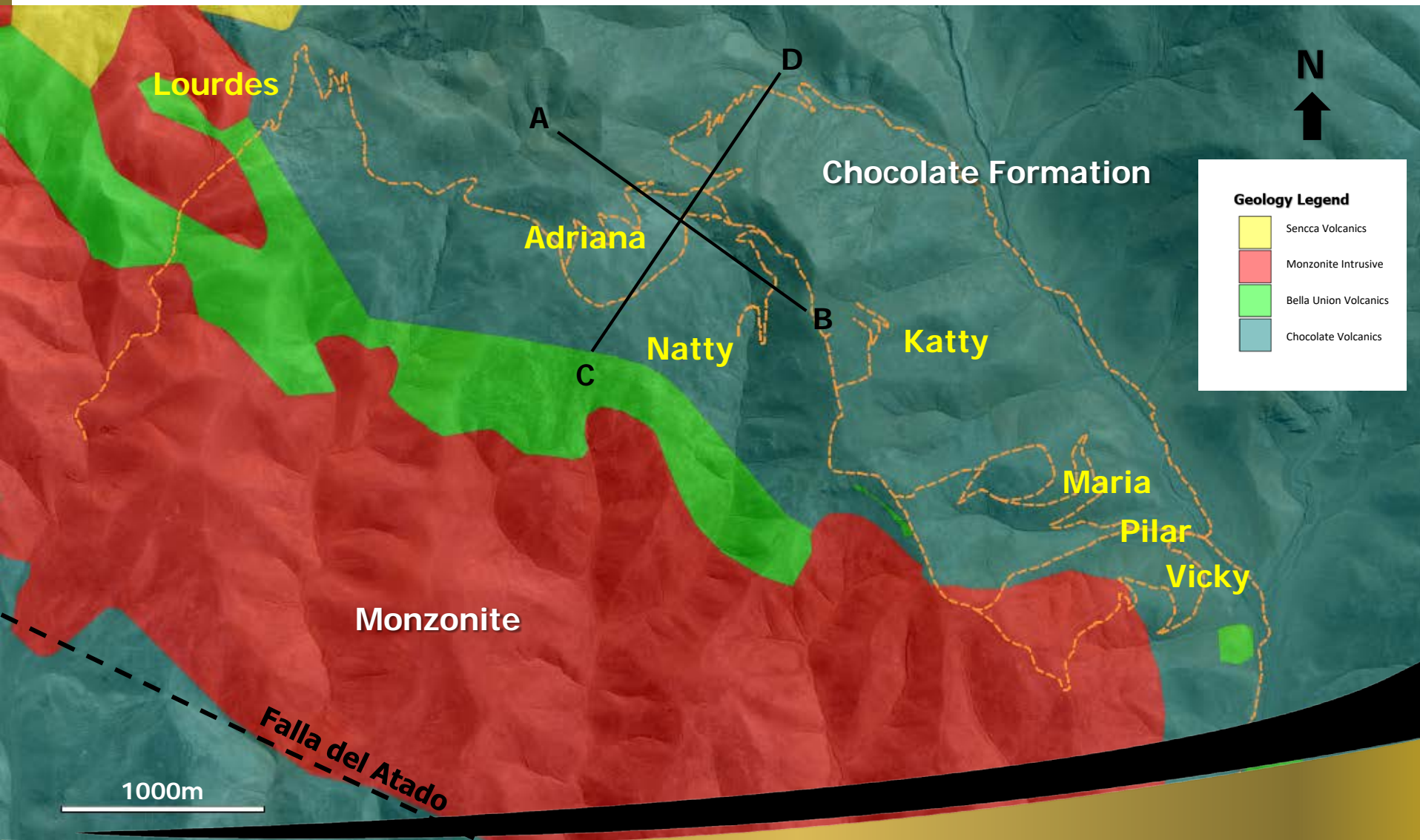

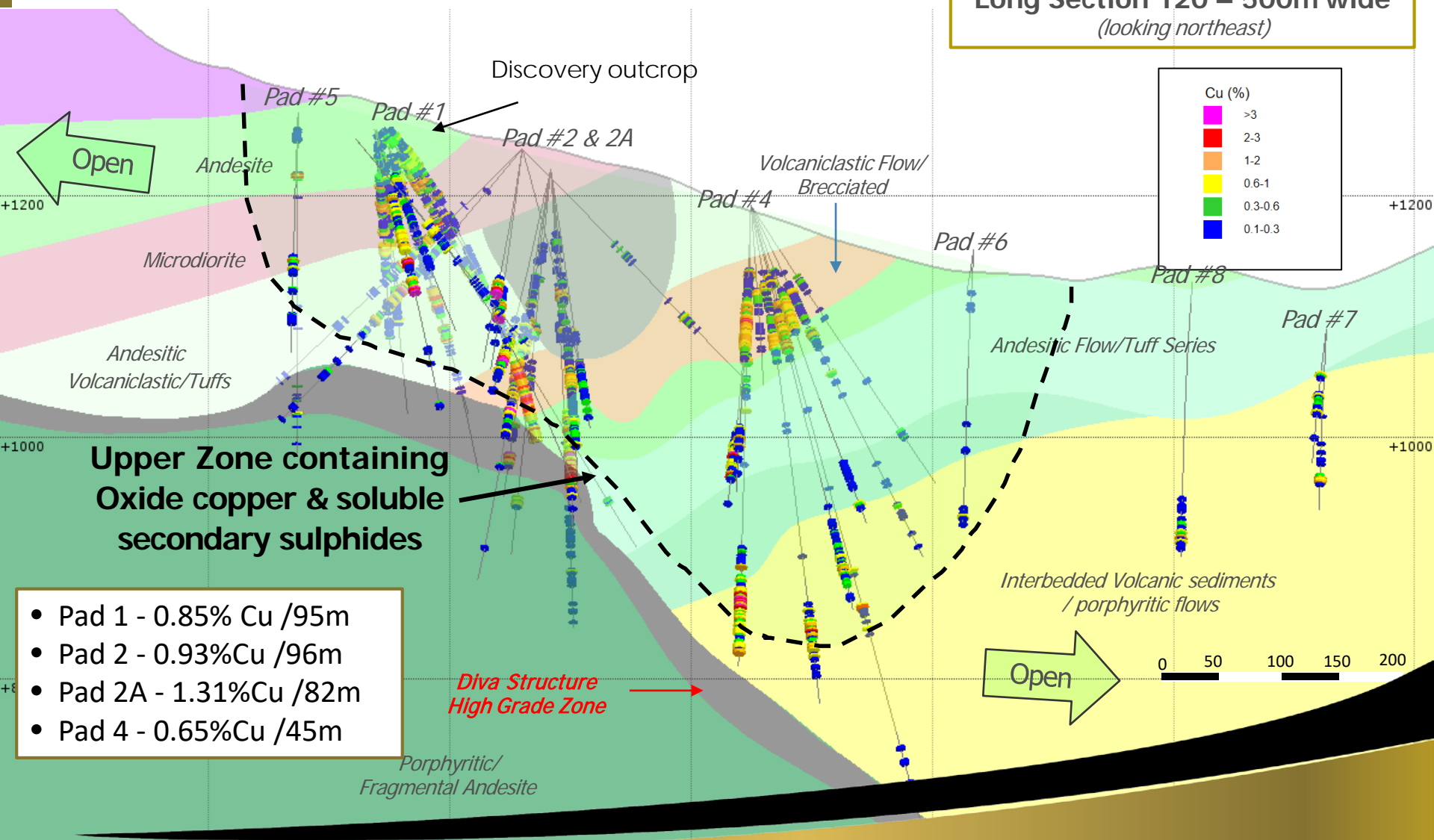




# 3D MODEL LONG SECTION A-B

(looking northeast)

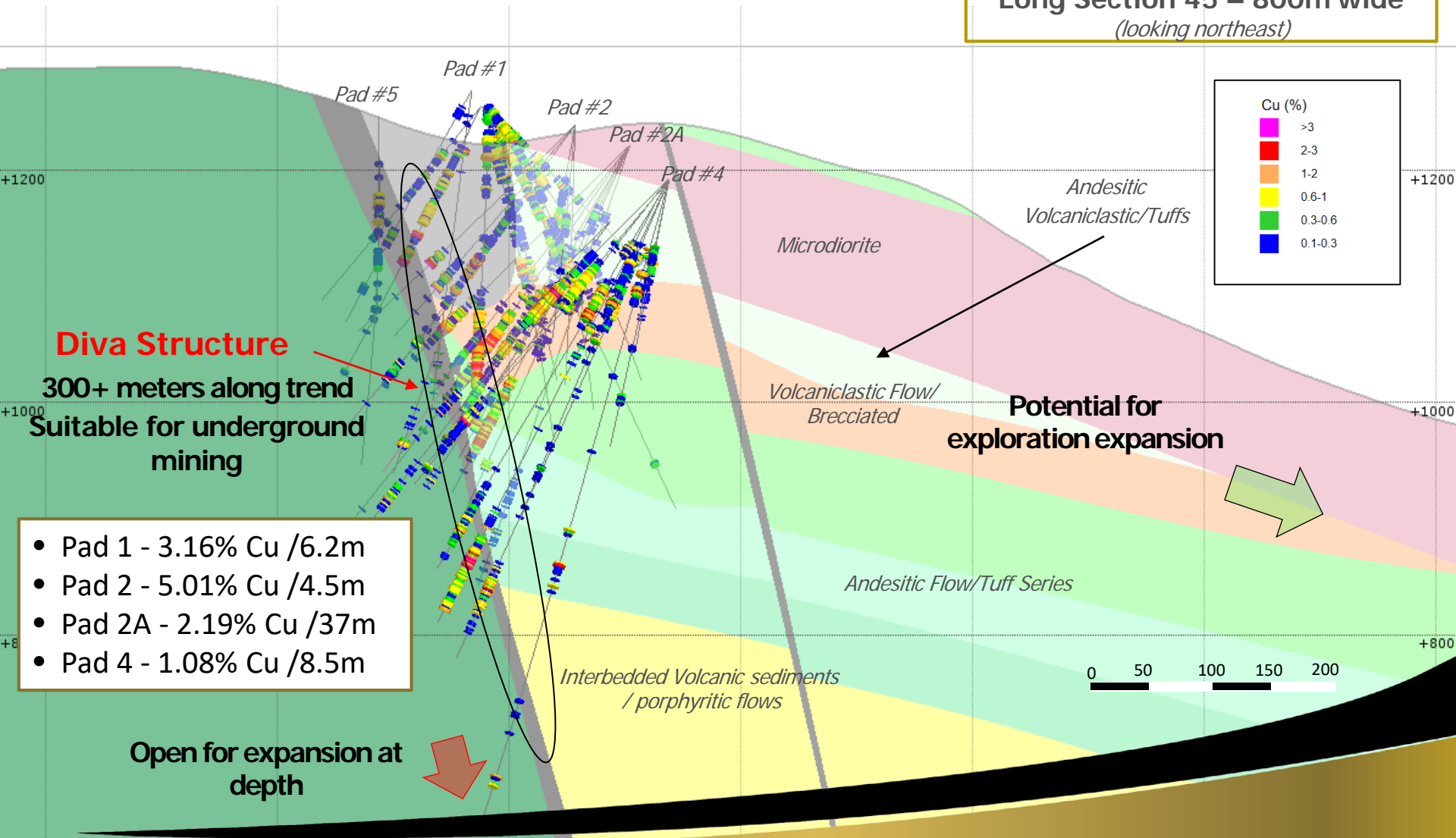

# 3D MODEL CROSS SECTION C-D

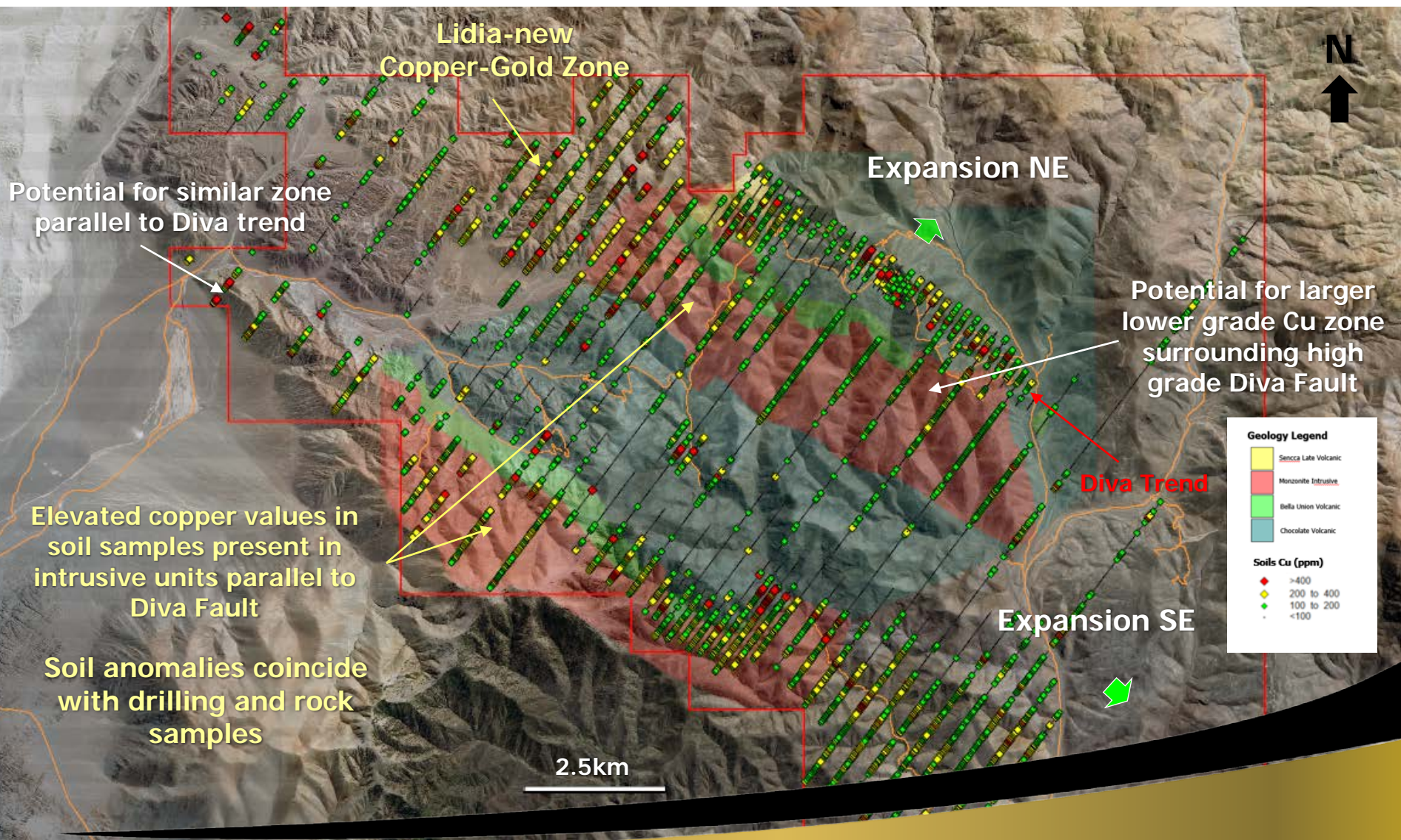
## Potential for Underground Mining

(looking northeast)



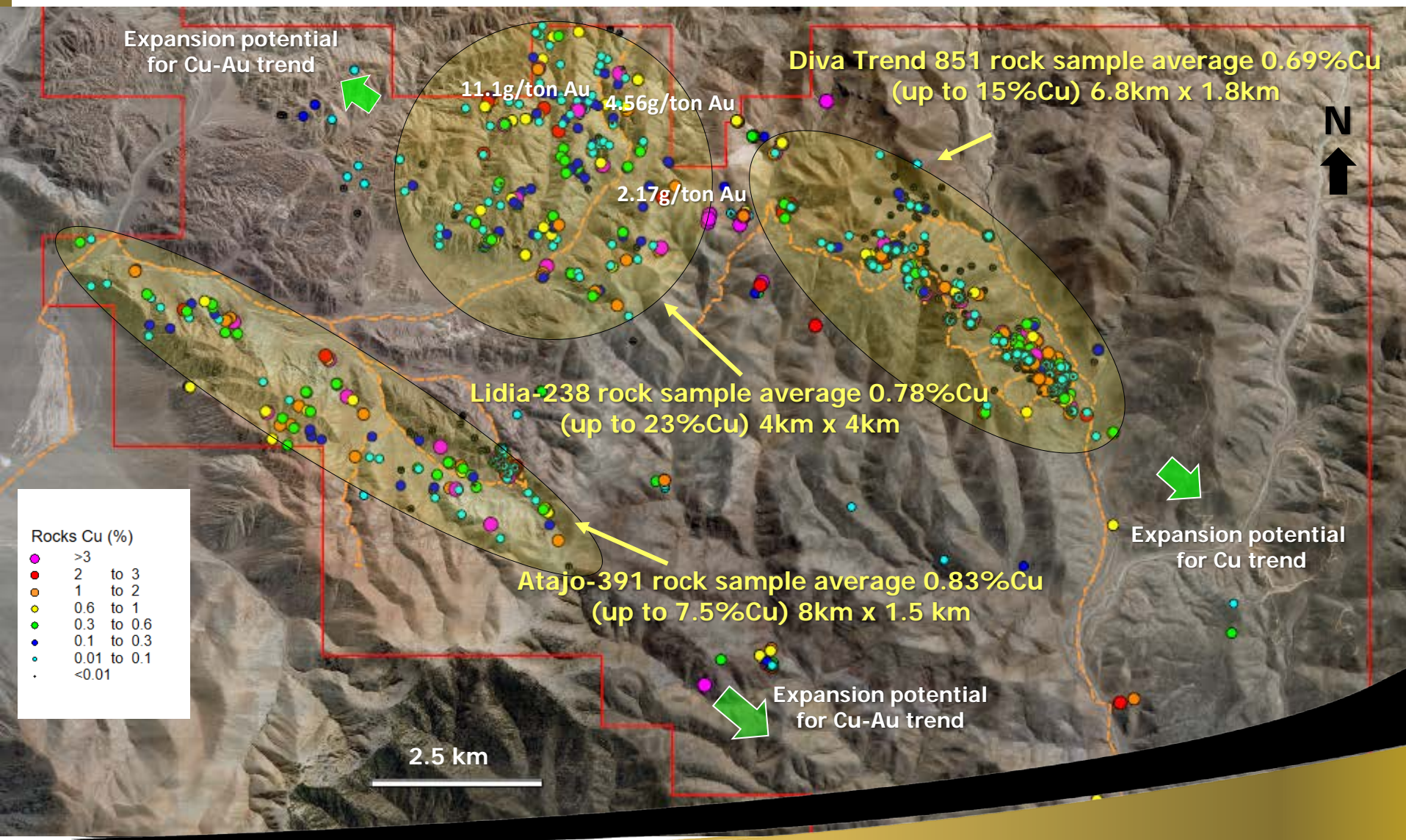
